



Subj: - Coming into force of the Orissa Entry Tax Act, 1999.

Sir,

In exercise of the powers conferred by sub-section (3) of section-1 of the Orissa Entry Tax Act, 1999 (Orissa Act 11 of 1999) Government of Orissa in the Finance Deptt. (vide Notification No. 44748/F., dated 4.11.1999) have been pleased to appoint the FIRST DAY OF DECEMBER, 1999 as the date on which the Orissa Entry Tax Act, 1999 shall come into force.

2. Accordingly, clause (kk) of sub-section (1) of section-131 of the Orissa Municipal Act, 1951 shall stand repealed as provided in section-41 of the Orissa Entry Tax Act, 1999.

3. In consequence, there shall be no Octroi Collection by the Municipal Bodies w.e.f. the First Day of December, 1999.

4. Separate guidelines will be issued regarding the redeployment of the functionaries engaged in Octroi work. Pending the same, I am directed to say that the Octroi functionaries be engaged in the following fields/works, with specification of targets and date lines:

- (i) Re-assessment and collection of holding tax and other Municipal Dues.
- (ii) Identification of New holdings,
- (iii) Collection of Licence fees, Market Rent, parking fees and other Miscellaneous fees,
- (iv) Execution of anti-poverty programmes, SURRY, identification of beneficiaries, collection of loan applications and sponsoring of the same to the banks.
- (v) supervision of sanitation works, Environmental and Pollution Control Measures.
- (vi) Municipal solid waste management and garbage disposal etc.
- (vii) Any other works of importance to be entrusted by the Municipal Council.
